Collection, Use and Disclosure of Personal Information

The web site published by MWKD from Sydney, Australia and accessible from www.davidsonlaw.com.au and www.davidsonandassociates.com deals with the collection, security, quality, use and disclosure of personal information in accordance with the *Privacy Act 1988* (Cth).

Collection and Use of Personal Information

Information provided by you to MWKD may be used by him in order to fulfil his functions under the *Legal Profession Act 2004* (**the Act**) and associated regulations.

Information provided by you may also be used to maintain his records, provide information to you, conduct research in order to identify and analyse the ongoing needs of clients and potential clients and to improve his practice and its practices, governance and risk management.

MWKD may approve the commercial use of his mailing list (including e-mail addresses) in a controlled manner to outside bodies proposing appropriate mail-outs. If you wish to have your name excluded from these commercial mailing lists, you should advise MWKD in writing by email to unsubscribe@davidsonlaw.com.au.

Disclosure of Personal Information

Information provided by you to MWKD may be disclosed to the Office of the Legal Services Commissioner, other regulatory bodies and insurance premium funders.

Information provided by you also may be disclosed to third parties as MWKD considers appropriate to further the prudent operation and management of his practise.

Consequences if All or Part of the Information is not Provided

You are required to provide certain information to MWKD pursuant to the Act. Other information may be sought. If you do not provide this information when requested, MWKD may not be able to deliver the service you require.

Access to Personal Information held by MWKD

You have the right to request access to any information held by MWKD, which relates to you. You also have the right to request the correction of any information which relates to you and is inaccurate. Any corrections should be advised to the MWKD in writing to mark@davidsonlaw.com.au.

Cookies

A cookie is a text-only string of information that a website transfers to the cookie file of the browser on the hard disk of a user's computer so that the website can remember that user. Without cookies, websites and their servers have no memory. This means that every time a user opens a new webpage on a website, the server where that webpage is stored will treat the user as new and require logon and password. In short, a cookie facilitates a user's passage through a website.

Types of Cookies

Cookies can either be "persistent" or "session" based. Persistent cookies are stored on a user's computer, contain an expiration date and may be used to track a user's browsing behaviour upon return to the issuing website. Session cookies are short-lived, are used only during a browsing session and expire when a user quits the browser.

Cookies and this Website

The cookies used on this website are persistent cookies but they are stored on a user's hard disk for a maximum period of two weeks.
